The price per camper is \$155 per session. For residents of Media Borough, the fees are \$95 per session thanks to the support of the Media Recreation Board. Campers participate in sports, games, arts & crafts, swimming, field trips, summer reading and more. Snacks are provided but campers must bring a packed lunch.
